HJC MEMBERSHIP: Early Childhood Center (ECC) families who are members of the Huntington Jewish Center (HJC) receive a significant discount on tuition and synagogue dues. From time to time, HJC offers additional membership incentives to ECC families. For information, contact the synagogue office at 631-427-1089.

ENROLLMENT of your child is for one full school year, or for the balance of the school year if enrolling during the school year. Tuition is non-refundable and non-transferable. No refund will be made due to withdrawal of the child by the parent(s) for any reason, except as described herein. In extreme circumstances where the school requests the withdrawal of the child for reasons consistent with the best interests of the school, an adjustment in rate may be considered by HJC's Finance Committee. There are no refunds for absences, school closings or snow days. A minimum number of children must be enrolled in a class, and you will receive a full refund if the class is cancelled. HJC will have no liability or obligation other than the refund of monies received. Enrollment is not final and placement is not assured until this completed and signed form is submitted with the required deposits. Only one mutual request will be considered for your child's placement. Teacher assignments and class placements are at the sole discretion of the Director.

PAYMENTS: This application must be accompanied by a non-refundable registration fee of \$50, plus a non-refundable tuition deposit equal to 10% of the total tuition plus fees. The remaining 90% of tuition and fees may be paid in 9 equal installments, by the 10th of each month starting in September. Credit card payments are subject to a 3% service fee. Cash is not accepted. Payments paid later than 14 days after they are due are subject to a \$25.00 late fee.

A parent(s) or guardian(s) that breaches this agreement shall pay to HJC the reasonable attorney's fees and costs incurred by it as a result of the breach of this agreement.
