**PAYMENTS:** This application must be accompanied by a non-refundable registration fee of \$50, plus a non-refundable tuition deposit equal to 10% of the total tuition plus fees. The remaining 90% of tuition and fees may be paid in 9 equal installments, due by the first of each month starting in September and continuing through and including May. Credit card payments are subject to a 3% service fee. Cash is not accepted. Statements are emailed on or about the 15<sup>th</sup> of each month and are due the first of each month. We offer a ten (10) day grace period after the 1<sup>st</sup> of each month, after that grace period has passed a \$25.00 late fee will be incurred if payment has not been made.

**ENROLLMENT** of your child is for one full school year, or for the balance of the school year if enrolling during the school year. Tuition is non-refundable and non-transferable. No refund will be made due to withdrawal of the child by the parent(s) for any reason, except as described herein. In extreme circumstances where the school requests the withdrawal of the child for reasons consistent with the best interests of the school, an adjustment in rate may be considered by HJC's Finance Committee. There are no refunds for absences, school closings or snow days. A minimum number of children must be enrolled in a class, and you will receive a full refund if the class is cancelled. HJC will have no liability or obligation other than the refund of monies received. If a specific class or school needs to convert to our virtual Zoom model of learning due to Covid related illnesses, there will be a reduction in the amount of tuition for that time period. **ENROLLMENT IS NOT FINAL AND PLACEMENT IS NOT ASSURED UNTIL THIS COMPLETED AND SIGNED FORM IS SUBMITTED WITH THE REQUIRED DEPOSITS.** Only one mutual request will be considered for your child's placement. Teacher assignments and class placements are at the sole discretion of the Director.

**HJC MEMBERSHIP:** Early Childhood Center (ECC) families who are members of the Huntington Jewish Center (HJC) receive a significant discount on tuition and synagogue dues. From time to time, HJC offers additional membership incentives to ECC families. For information, contact the synagogue office at 631-427-1089. Please note that membership dues must be paid in full by 12/30/21 or nonmember rates will apply.

A parent(s) or guardian(s) that breaches this agreement shall pay to HJC the reasonable attorney's fees and costs incurred by it as a result of the breach of this agreement.
